

REAL ESTATE STANDARDS ORGANIZATION (RESO) WEBSITE TERMS AND CONDITIONS OF USE

RESO sites, www.reso.org, and other sites owned or operated by RESO on which this policy appears or is linked ("Site" or "Sites") are owned, operated, and maintained by Real Estate Standards Organization ("RESO"). Please read these terms and conditions of use ("Terms") carefully. By accessing this Site, you indicate your agreement to be bound by these Terms in full, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable laws.
