

The Interoperability Workgroup will study submitted business cases, partner with affected stakeholders and coordinate solutions that will produce ease and efficiency of business through the creation, maintenance and evolution of RESO Interoperability standards for the community.



  - ActorType: Roles that are typically involved in a transaction, requiring a level of access or permission (Will use existing MemberType and TeamMemberType)
  - DocumentStatus: Statuses a document could be in during a transaction
  - **TaskType**: Tasks used during a transaction, commonly associated with a checklist feature
  - **Permission**: Level of access attached to action, document, user, etc.


